

**ANNOUNCEMENT OF THE NATIONAL ELECTORAL COMMISSION
AFTER THE PRESS CONFERENCE HELD ON
22 NOVEMBER 2010 AT 5.15 A.M. CET AT THE NEC'S HEADQUARTERS**

On 22nd November 2010 at 5:15 a.m. CET at the headquarters of the National Electoral Commission, another press conference about the elections for municipal councils, county councils and regional assemblies, as well as for the positions of reeves, mayors and presidents of cities was held.

Judge Andrzej Mączyński announced partial unofficial results of voting as of 4.52 a.m. CET based on electronically obtained data from 34 296 out of the total of 104 008 protocols approved by territorial electoral commissions.

The turnout in elections for the positions of reeves, mayors and presidents of cities amounted to 45.52%. Out of the total number of 2 479 reeves, mayors and presidents of cities elected, results were established in 10 communes and cities. The turnout in elections for municipal councils amounted to 45.61%. Out of the total number of 2 479 communes, results were established in 9 communes. The turnout in elections for county councils amounted to 45.38%. Out of the total number of 314 counties, results were not established in any of the counties. The turnout in elections for regional assemblies amounted to 41.18%. Out of the total number of 16 regional assemblies, results were not established in any of the regional assemblies.

Judge Janusz Niemcewicz presented the results of voting for presidents in selected cities, giving the results of three candidates with the highest number of votes.

Judge Andrzej Mączyński presented percentage results of voting for municipal councils, county councils and regional assemblies by electoral committees operating countrywide in individual provinces.

Next partial unofficial results of voting may be expected after the National Electoral Commission obtains 60% of protocols from electoral commissions.

On the basis of electronically obtained information about the results from 34 296 protocols of precinct voting, approved by territorial electoral commissions, out of the total of 104 008 voting protocols, the National Electoral Commission announces that partial unofficial results of the ballot are as follows:

I.

1. In elections for the positions of reeves, mayors and presidents of cities:
1) the number of people eligible to vote amounted to 11 751 056;
2) the number of valid ballot papers amounted to 5 349 343;
3) the turnout was 45.52% ;
4) out of the total number of 2 479 reeves, mayors and presidents of cities elected, results were established in 10 communes and cities.
2. In elections for municipal councils:
1)) the number of people eligible to vote amounted to 11 417 505;
2) the number of valid ballot papers amounted to 5 207 991;
3) the turnout was 45.61% ;
4) out of the total number of 2479 communes, results were established in the case of 9 municipal councils;
5) out of the total number of 18 districts of the capital city of Warsaw, the results were not established in any of the district councils.
3. In elections for county councils:
1)) the number of people eligible to vote amounted to 1 706 969;
2 the number of valid ballot papers amounted to 774 674;
3) the turnout was 45.38% ;
4)) out of the total number of 314 counties, the results were not established in the case of any of the counties.
4. In elections for regional assemblies:
1)) the number of people eligible to vote amounted to 5 657 058;
2) the number of valid ballot papers amounted to 2 329 535;
3) the turnout was 41.18% ;
4) out of the total number of 16 regional assemblies, the results were not established in any of the provinces.
